2. Diweddariad ar Brosiect yr Is-orsaf

Rhoddwyd diweddariad ar y prosiect arfaethedig i ddarparu is-orsaf o fewn y Cymuned i gysylltu â phrosiect Ynni Bute.

Darparwyd gwybodaeth mewn perthynas â'r broses ar gyfer nodi'r safle a ffeirir. Roedd hyn yn cynnwys cynnal astudiaeth safle, roedd y cynnig yn dilyn y canllawiau i ddarparu'r seilwaith hwn o fewn 2cm i'r llinellau uwchben presennol. Nodwyd roedd angen is-orsaf newydd p'un a oedd prosiect Bute Energy yn mynd yn ei flaen ai peidio.

Cadarnhawyd y safle a ffeirir o fewn ardal Idole i Landyfaelog. Roedd trafodaethau yn cael eu cymryd yn awr gyda thirfeddianwyr.

Trafodwyd amserlen y cais cynllunio gydag ymgynghoriad yn Ionawr neu Chwefror a chyflwyniad cais cynllunio yng Ngwanwyn 2024. Trafodwyd proses bosibl ar gyfer yr ymgynghoriad ynghyd â digwyddiadau cymunedol a chyhoeddusrwydd.

Trafodwyd maint yr is-orsaf ac amcangyfrifwyd ei fod tua 300m x 300m. Pe na bai Prosiect Bute yn mynd yn ei flaen roedd angen yr is-orsaf ond gallai fod yn ddatblygiad llai.

Nodwyd nad oedd unrhyw gynlluniau ar gyfer llinellau ychwanegol i redeg o'r is-orsaf. Trafodwyd yr effaith ar drigolion, pryderon amgylcheddol a'r defnydd o gontractwyr lleol.

2. Substation Project Update

An update was provided on the proposed project to provide a substation within the Community to connect to the Bute Energy project.

Information was provided in relation to the process for identifying the preferred site. This included carrying out a siting study, the proposal followed the guidelines to provide this infrastructure within 2km of the existing overhead lines. It was noted that a new substation was required whether the Bute Energy project went ahead or not .

The preferred site was confirmed within the Idole to Llandyfaelog area. Negotiations were now being undertaken with landowners.

The timetable for the planning application was discussed with a consultation in January or February and submission of the planning application in Spring 2024. The possible process for the consultation was discussed along with community events and publicity.

The size of the substation was discussed and was estimated to be around 300m x 300m. If the Bute Project did not go ahead the substation was still required but may be a smaller development.

It was noted that there were no plans for additional lines to run from the substation. The impact on residents, environmental concerns and use of local contractors were discussed.
