2. Planning Application PL/01633 - Proposed erection of 5 glamping pods and associated works, Land at Capel Farm, Bancycapel, Carmarthen, SA32 8EB

The Clerk confirmed that no further information had come to hand on the matter from the Planning Department. It was agreed to request an extension on the consultation period for the Council pending receipt of the requested information on previous application refusals at this location.

3. Peter Williams Heritage Tour

The Clerk confirmed that an email had been received from the campaign group confirming that they had received a grant for the proposed heritage walking tour. This was to include QR code signs leading to a website with historical information. The Clerk provided detail received of possible wording for the website.
